Air Transfer: Omniflife reserves the right to assign the departure airport according to your home city.

Ground transfer: Airport-hotel-airport.

Lodging: 4 nights

Adventure Combo: Canopy and Class 3 Rafting + breakfast, lunch and dinner.

Adventure Combo: ATV and horseback riding + lunch.

Daily Breakfast at the Hotel.

Travel medical insurance.

Requirements:

- 1- Have entered into a contractual agreement as an Independent Distributor with Omniflife USA, Inc. Contract must remain valid throughout the qualification period.
- 2- Participation can begin in February or March 2019, you must be registered to participate for this Contest. Monthly periods, required points and the registration code are specified in the "Target Table."
- 3- To participate in the trips listed on the "Target Tables" VIAJOU19, VIJOU219, VIJOU319, VIJOU419 you must be 18 years of age or older on September 30, 2019 and 33 years of age or younger on February 1, 2019, both for the Card Holder and for the Co-Distributor; in case the Card Holder does not reach the age allowed and the Co-Distributor does, the latter may participate, by requesting simple registration and notifying that the participant is the Co-Distributor.
- 4- In the event that the Owner or Co-Distributor of the Independent Distribution contract is older than 33 years but younger than 39 years old as of September 30, 2019, they may only participate twice, that is to say: one of the members of the Contract must be between 18 and 33 years old and the other member between 34 and 39 years old, for the foregoing they must participate in the "Target Tables" "Nfuerza and Nfuerza Plus": VIJOU519, VIJOU619, VIJOU719 or VIJOU819.
- 5- In addition to complying with the above points, persons with special needs must double qualify so that they can be accompanied and supported by their companion/ Co-Distributor for their safety. In case of any doubt on this point please contact the department of Nfuerza.
- 6- The points must be national, considering the following:
 - a. Each monthly period you must meet at least 2,500 personal points.
 - b. The remaining score that corresponds to you may be of the Entrepreneurs that make up your Distribution Network, considering the following:
 - They do not have 40% fixed discount and do not depend on an Entrepreneur who has a 40% fixed discount.
 - You will not be able to use the points of Entrepreneurs that are qualifying this or any other Contest/ Incentive, or those of his/her network.
- 7- It is important to take into account the monthly period closing dates since points will only be considered within the monthly invoiced period.
- 8- Points are not cumulative or transferable for any other Contest / Incentive or Event. If you do not indicate qualifying priorities - that is, notify you that you are participating in another Contest /Incentive or Event - Omniflife will assign the points at their discretion.
- 9- You must have a valid passport and visa (if necessary). Passport and visa payments, as well as entry and exit taxes and other expenses generated by these concepts, are the responsibility of the Distributor. No later than August 31, 2019, you must deliver to the Distribution Center of your choice the copies of the above documents, with minimum validity of June 30, 2020. In case the Distributor or Co-Distributor does not have a passport or visa, or they do not comply with the established validity, they will not be able to validate their qualification for the trip and Omniflife shall be exempt from any responsibility.
- 10- Purchases must be settled with the resources of the holder and/or Co-Distributor of each Distribution Agreement,

therefore it is prohibited to make payments with third-party debit or credit cards.

- 11- The resources used to participate in the present event must come from the legitimate activities of the titular Distributor and/or his Co-Distributor.

Important:

- OMNILIFE does not assume responsibility for special situations in Costa Rica, as -but not limiting to- meteorological phenomena, acts of government and other authorities, civil disorder, war, epidemics, quarantines, strikes or any other situation that is unsafe or that may affect the organization. The distributor claims to be aware of this and free OMNILIFE from any claim that may arise from it.
- Within the first qualifying period you must notify Omnilife if your qualification includes your Co-Distributor and your child(ren). If it is not completed within the aforementioned period, only you will be able to attend, even if you have reached the required score to attend with your Co- Distributor and children.
- Once the qualification period has started, no changes or cancellations in regards to the Co-Distributor are allowed.
- All expenses of both the Independent Distributor and his / her companions, which are not considered as included in this base document, shall be covered by the person who incurs them. For example: transportation from the city of residence to the Omnilife assigned airport or bus terminal, telephone calls, medical expenses, payment for flight or missed connection, additional accommodations, tours, entertainment tickets, mini bar consumption, room service charges, pay TV channels, lodging for delayed/modified transportation that cannot be attributed to Omnilife, among others.
- To make any modifications such as: change of address, change to another contest/incentive or event, etc., you must submit a request for the change you want to make at any Omnilife Distribution Center (CEDIS), or you can send it directly to the Multidevelopment department no later than August 31, 2019. No changes will be made after this date.

- Each month, you will be able to see the status of your qualification to this event on the purchase invoices, on the Omnilife mobile APP, in the Distributor Zone on the Omnilife page and/or on the notice boards; if you detect any error, please report it immediately to CREO, your nearest CEDIS or send an email to: ajustes@omnilife.com.mx

Final Provisions:

- Any evidence of manipulation of points, modification of data or documents, use of incorrect information or irregular practices in order to qualify the contest / incentive, will be grounds for automatic disqualification, without recourse and Omnilife responsibility.
- The list of participants will be published periodically by Omnilife official communications, if any Distributor does not want his/her data to be published, or that they are part of these lists must notify to the following email: ajustes@omnilife.com.mx
